This **SERVICE ORDER FOR ANALYTICAL TESTING SERVICES** (this **"Agreement"**) is entered into by the Parties on the following terms:

- 1. Services.**  
 MXNS shall provide to Customer the analytical testing services outlined in the Schedule of Services and Fees above (the **"Services"**). Certain Services might be performed by subcontracted laboratories outside the MXNS network, in which case the subcontracted laboratory will be identified on the COA.
- 2. Procedures.**  
 Customer must send to MXNS: (i) the applicable samples for testing in accordance with the Schedule of Services and Fees above, (ii) a completed Sample Analysis Request Form (**"SARF"**), (iii) any purchase orders as indicated in the Customer Account Setup Form, and (iv) pre-payment, as applicable.
- 3. Term.**  
 This Agreement will begin on the date of Customer's signature below (the **"Effective Date"**) and remain in effect through December 31, 2024 (the **"Initial Term"**). Unless terminated as provided for herein, this Agreement shall automatically renew for successive periods of one (1) year each (each, a **"Renewal Term"**), and, collectively with the Initial Term, the **"Term"**), subject to the payment by Customer of the corresponding fees, with either Party having the ability to provide the other Party with written notice of its intent not to renew at least thirty (30) days prior to the end of the applicable term.
- 4. Fees.**  
 Customer agrees to pay for the Services in accordance with the Schedule of Services and Fees above. An environmental fee of \$5/sample may apply for the processing and disposal of microbiological and/or chemical waste.
- Invoicing.**  
 MXNS will invoice Customer for the Services on a bimonthly basis throughout the Term upon completion of the Services. If multiple testing requests are made on the SARF, multiple invoices may apply due to Microbiological, Allergen, Chemistry and other testing programs having variations on the turnaround time completion dates and invoices being generated when the testing program is completed.
- Terms & Conditions.**  
 Except as otherwise stated above, the Services are governed exclusively by Mérieux NutriSciences' General Terms and Conditions for Services (the **"General T&Cs"**) and the Supplemental Terms and Conditions for Analytical Testing Services (the **"Testing Services Terms"**), which are hereby incorporated by reference into this Agreement.
